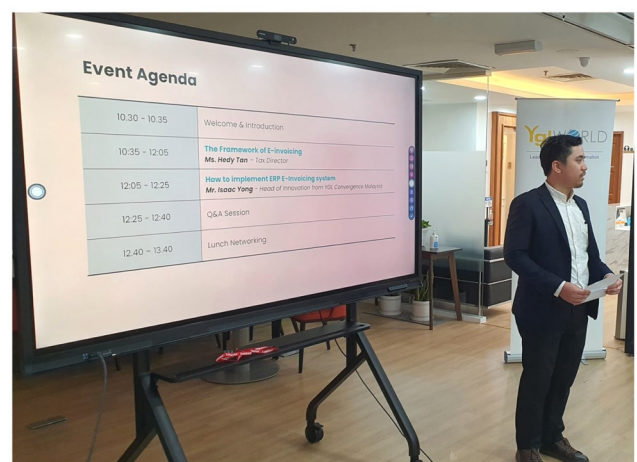


On March 7, 2024

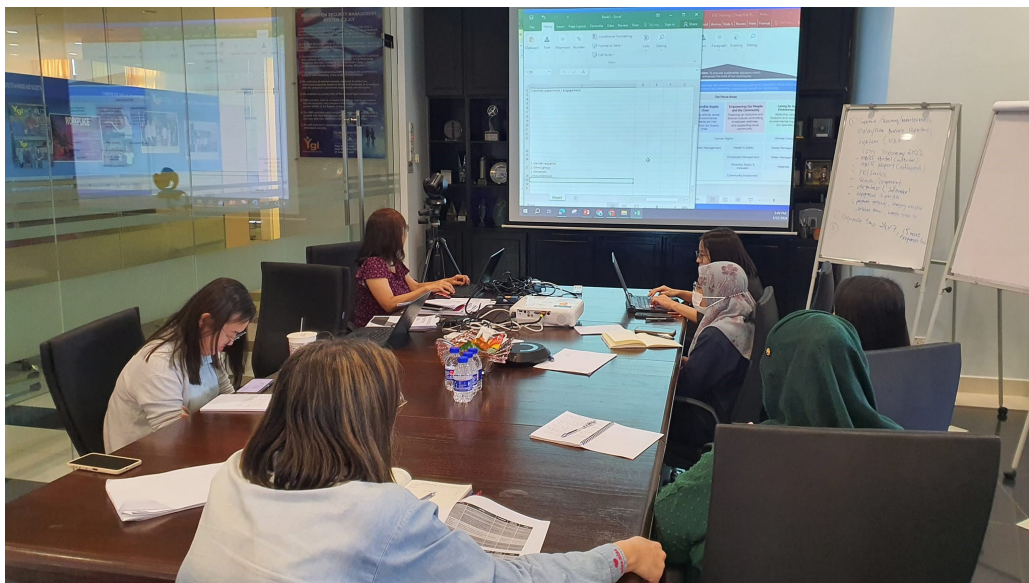
